1. COMPETITION SUBCOMMITTEE.

1. COMPETITION SUBCOMMITTEE.

1.1 1.2		The Competition Committee shall be constituted for the purposes described in Rule 38. There shall be one Association Umpires Manager, who shall be appointed by the Umpires Committee.
1.3		The Competition Committee shall consist of
1.0	1.3.1 1.3.2	the Competition Committee chairperson, who shall be elected at the Annual General Meeting, members of the Match Committee, who shall be elected at the first Competition Committee

1.4	1.3.3	delegates of affiliated clubs, as described in Rule 38.
1.4		The Competition Committee shall have a Match Committee, which shall consist of the
		Chairperson of the Competition Committee, six elected members and the Association Umpires Manager
	1.4.1	The Match Committee shall be responsible for overseeing registrations of players,
	1.4.1	management of results for all competitions and any other duties as directed by the
		Competition Committee.
	1.4.2	The Match Committee shall be empowered to make decisions regarding clearances, match
		cancellations and rescheduling, and is responsible for the preparation of the Winter fixture.
	1.4.3	A quorum for a meeting of the Match Committee shall be 3.
1.5		Affiliated clubs shall register with the Secretary on the appropriate form each year details of
		appointed delegates to the Committees as required from time to time.
	1.5.1	Only delegates who have been duly registered with the Association are entitled to vote at a meeting of the Competition Committee.
	1.5.2	Clubs must notify the Secretary on the appropriate form of the resignation of a delegate.
	1.5.3	Each affiliated club must be represented at any meeting of the Competition Committee by at least one delegate.
1.6		In the event of a casual vacancy occurring in any position filled in accordance with this By-
		Law, the Competition Committee shall appoint a replacement.
1.7		A quorum for a meeting of the Competition Committee shall be the number of delegates equal to the number of affiliated clubs, provided that at least 50% of affiliated clubs or associations
		are represented.
1.8		If a registered delegate is unable to attend a meeting of the Committee, they may give written
		notification prior to the meeting of the assignment of their proxy vote to another member of their club or to a registered delegate of another club.
1.9		A fine shall be levied on those clubs who are unrepresented at a meeting of the Competition
1 10		Committee where no apology or proxy vote is received.
1.10		Apologies or proxy votes will only be accepted for two meetings in succession. After this time, if not represented in person, the Club shall be fined the appropriate amount.



2. ROLE OF COMPETITION COMMITTEE AND ELECTED MEMBERS.

2.1		The Role of the Competition Committee will be to oversee the conduct of Men's, Women's and Junior competitions of Hockey Geelong.
	2.1.1	At the first Competition Committee meeting of the year, the Competition Committee will set the dates for the start and end of the home and away season, to allow fixture preparation by the Match Committee.
	2.1.2	The Competition Committee is empowered to make, amend or rescind bylaws to administer and control the relevant competitions under its' control.
	2.1.3	All decisions made by the Competition Committee shall only become effective following ratification by the Committee of Management of the Association.
2.2		The Competition Committee members elected to specific positions shall perform the duties as specified in the G.H.A. Procedures Manual as amended from time to time and undertake such other duties as directed by the Competition Committee.
2.3		The Committee shall meet at least twice during the winter season, and at such other times as are deemed necessary by the Committee.
2.4		At least 14 days notice of a meeting of the Competition Committee shall be given in writing to all registered delegates and appointees to the Committee, unless by special agreement to the contrary of the Committee.
2.5		Competition By-Laws shall be made, amended or rescinded by the Competition Committee of the Association in the following manner:
	2.5.1	Notice of Motion of the proposed alteration shall be given at least 14 days before a meeting of the Competition Committee and may be dealt with at the next meeting.
	2.5.2	No alteration shall be made unless supported by at least two thirds of those members present who are entitled to vote.

2.6 Any proposed alteration shall not be contrary to the Rules and Statement of Purposes of the Association.



3. ENTRY OF TEAMS.

- 3.1 Affiliated Clubs or Associations may apply to enter teams in the Competitions of the Association by forwarding a completed entry form by the given date to the Secretary, giving all information as required.
- 3.2 The acceptance of any applications made under By-Law 3.1 shall be at the discretion of the Competition Sub-Committee.
- 3.3 Late entries may be accepted at the discretion of the Match Committee.
- 3.4 A non-refundable deposit shall accompany each senior team competition nomination before acceptance of that nomination.
 - 3.4.1 Any Club defaulting in the previous year may be required to pay twice the sum of the deposit in the next year.
 - 3.4.2 The deposit will be taken as a credit toward the yearly competition fee.
- 3.5 Any club may by notice in writing to the Secretary withdraw any of its teams. Any club doing so will forfeit their deposit, to the funds of the Association. If the team is withdrawn during the season, the Match Committee of the appropriate Competition will decide how the points, goals etc. will be allocated.



4. UNIFORMS.

4.1		Each club shall register in writing with the Association its playing uniform.
4.2		The Competition Subcommittee may grant or refuse permission for a club to wear that uniform.
4.3		Such playing uniforms may be altered from time to time with the approval of the Competition Subcommittee.
4.4		Registered uniforms of existing clubs are not subject to change except at the request or with the approval of that club.
	4.4.1	Women club uniforms may include shorts or skirts.
4.5		All players are required to play in registered club colours. The goalkeeper may wear a tracksuit or similar apparel over his/ her registered shirt, unless objected to by the opposing captain and/or umpire.
4.6		Each player (except the goalkeeper) shall wear a distinguishing number on the back of his/her shirt. The number shall be at least 200 mm high.
	4.6.1	All players in the one team shall have unique numbers which shall be recorded on the team sheet.
4.7		If there is a conflict in the uniforms of any teams competing against each other, the visiting team shall wear an alternative uniform.
4.8		The Competition Subcommittee Convenor shall keep a register of Club colours and uniforms.
4.9		After a team has played two fixtured matches, all players must be in the registered uniform unless approval has been given by the Match Committee. Such approval shall be recorded on the back of the scorecard.
	4.9.1	Only two such approvals shall be given to the same player.
4.10		Any infringement of this rule is to be noted on the match report by the umpire.
4.11		Failure to comply with By-Law 4 after two matches have been played by the team will attract a fine.



5. <u>REGISTRATIONS.</u>

- 5.1 A person shall become eligible to take part in matches organised by or conducted under the auspice of the Association upon registration by an affiliated club at the start of each season.
 5.2 Each club must submit to the Association a Player Registration form each season, giving required details of all players.
- 5.3 A player shall be registered with that club after his/ her name appears on the Team Registration form.
- 5.4 The completed registration form shall be forwarded to reach the Association at least one week prior to the first match of the season.
- 5.5 Any players not named on the Team Registration sheet may be field registered on the back of the team sheet and shall be eligible to play in that match,
- 5.6 If any club plays an unregistered player/s, the club shall be notified of the fact by the Records Secretary, and shall be fined. If the club fails to forward a registration within a further 7 days of being notified the match shall be awarded to the opponents as a forfeit, and the club shall be fined.
- 5.7 A member can only be registered with one club within the Association at any one time and upon transferring to another club shall be registered again by that club, thereby making any previous registration void. Transferring players must state previous club.
 - 5.7.1 Junior players may be registered with a second club for senior competition.
 - 5.7.2 A team which is participating in a junior match may include 2 players who are registered with a different club providing that
 - 5.7.2.1 the team has 7 of its registered players available to start the match
 - 5.7.2.2 the team will have no more than 11 players including the players from a different club
 - 5.7.2.3 the agreement of the captain or coach of the opposing team has been given
 - 5.7.2.4 an individual may play with a different club from the club with which he/ she is registered for a maximum of 20% of the home and away matches for the season
- 5.8 If both teams in a match field unregistered players and fail to register in accordance with the above, no premiership points shall be awarded for the match, and each team shall have five (5) goals awarded against it, and each club shall be fined the same amount as that applicable under 5.6.
- 5.9 The team sheet or whatever other form is at the time in use by the Association, shall be the complete evidence as to whether or not a player competed in the match.
- 5.10 For the purposes of these By-Laws a player shall cease to be a member of a Club if he/ she has not been a registered member of that Club for one complete season.
- 5.11 The Competition Sub-Committee may refuse the registration of any person.
- 5.12 Players may participate without restriction in other competitions outside the auspices of the Association, subject to the rules of the Associations concerned and the State Associations.



6. CLEARANCES. (Request for Transfer)

- 6.1 A player desiring to transfer from one club to another within the Association, shall, prior to playing with the proposed club, submit to the Match Committee Convenor, the appropriate details in writing on an official transfer request form.
- The transfer form shall be signed by the player requesting the transfer, a member of the 6.2 Committee of Management of the player's previous club, and a member of the Committee of Management of the club the player desires to play with.
- The Match Committee Convenor will advise the applicant's previous club of the transfer 6.3 request, and will request a reply within seven (7) days indicating if the request is granted or denied.
 - Where a transfer form is submitted without a signature from the player's previous club, the 6.3.1 Match Committee Convenor will advise the applicant's previous club of the transfer request, and will request a reply within seven (7) days indicating if the request is granted or denied.
 - 6.3.2 If the applicant's previous Club fails to reply within the seven (7) day period, the Match Committee Convenor will deem the request granted.
- Unless exceptional circumstances exist, outstanding financial commitment by the individual 6.4 shall be the only basis for refusal of a transfer request. 6.5
 - Clubs may lodge an appeal against the outcome of a transfer request.
 - 6.5.1 Such appeals must be lodged, in writing, within seven (7) days of notification of the outcome of the application.
 - 6.5.2 Such appeals shall be heard by the Match Committee.
 - 6.5.3 Such appeals will be held within seven (7) days from the date of receipt of the written request.
 - 6.5.4 The Secretary shall notify the clubs concerned of the date set for the hearing of the appeal, and the player in question shall not be eligible to play in any matches until the dispute is resolved.
- 6.6 Failure to comply with 6.1 will result in the forfeit of the match or matches by the team for which the player has played whilst ineligible.
 - 6.6.1 If both teams in a match field ineligible players, no premiership points shall be awarded for the match, and each team shall have five (5) goals awarded against it.
- 6.7 Transfer requests under 6.1 will not be considered after June 30.
- The Association will have the power to revoke a transfer request up to twelve (12) months 6.8 after it has been issued, if the first club subsequently disbands or is disaffiliated, whilst owing monies to the Association.
- 6.9 No player whose transfer request has been revoked, or who has been a registered member of a club within twelve (12) months previous to the club disbanding or being disaffiliated whilst owing monies to the Association, may play with a second club until the Association is satisfied that he/ she has made an appropriate contribution towards reducing the amount owed to the Association by the club, and has received from the Association a written statement advising him/ her that he/ she may do so.
- 6.10 A player does require a clearance to transfer if they have not been a registered member of a club for one complete season as set out in By-Law 5.10 if the player owes money to their previous club.



7. COMPETITION.

7.1			The rules of the game of hockey as adopted and issued under the authority of the
			F.I.H. Hockey Rules Board and the local rules of this Association shall be observed in all matches under the auspices of the Association.
	7. 1.1		Where a competition is specified as a women's competition, only female players may participate.
	7.1.2		Where a competition is specified as a men's competition, only male players may participate.
	7.1.3		If a competition is specified as a senior competition, players must be at least the age of twelve (12) as at 1 January of that year to participate. Exemption from this By-Law may be sought from the Competition Convenor in exceptional circumstances.
7.2			The structure of the competition, the number of divisions and the number of teams in each division shall be determined each season by the Match Committee of each Competition Subcommittee and proposed gradings circulated for approval by clubs at least 30 days prior to the commencement of the season.
	7.2.1		Teams may be promoted or relegated each season from one division to another at the discretion of the Match Committee.
		7.2.1.1	The winner of the Division Two Grand Final will be automatically promoted to Division One in the next season, and
			The last placed team in Division One will be relegated to Division Two for the next season, unless they request to remain in Division 1.
	7.2.2		Clubs may lodge a written appeal against the grading of their teams, and shall furnish details of the basis of their appeal.
		7.2.2.1 7.2.2.2	Such appeals shall be lodged within 7 days of circulation of the proposed gradings. Such appeals shall be heard by the Competition Subcommittee.
	7.2.3		Where a club has more than one team in a senior division, the teams shall be nominated as higher and lower graded.
7.3			The Match Committee shall prepare a fixture each season, stipulating times and locations of matches.
7.4			Matches shall be played as arranged in the fixtures but may by mutual agreement of the competing teams be altered as to time and place subject to approval being given by the Match Committee.
	7.4.1		Upon granting approval for alteration to fixtured matches, the Match Committee Chairperson will notify the relevant personnel of the change (grounds manager,
	7.4.2		umpires convenor, canteen manager, pavilion manager etc.) Both clubs must fulfill responsibilities as published previously (provide umpires,
7.5	7.4.3		canteen roster etc). The rescheduled game should be played within four weeks of the fixtured date. In the event of a team failing to play as fixtured, unless notification has been given
			under By-Law 8.3.3, a 5-0 forfeit shall be awarded against them and that team shall be responsible for all expenses incurred, including the entire cost of pitch hire and umpires.
	7.5.1		Clubs who are unable to meet a rostered commitment may apply to the Association in writing, with at least 30 days notice, requesting that the roster be changed.
7.6			In exceptional circumstances where a club has not fulfilled its obligation but with good cause, negotiation for rematch must be commenced within a few days and the
7.7			Competition Sub-Committee Convenor and Records Secretary informed. All home and away matches should be completed at least 6 days prior to the

		(ii)	If there is a tie for Best and Fairest, both players shall be awarded the Best and
			Fairest award for the grade as joint winners.

			cumulative across teams.
		(iv)	If a team is regraded during the season any votes awarded to players within that

7.12			Demerit Points
			All players begin each season on zero (0) demerit points.
	7.12.2		Any player who receives fifteen (15) demerit points within any eight (8) week period
			shall be automatically suspended for the next round in which his/her club has teams
			competing, even if the next round is a finals round.
		(i)	The Competition Convenor or Association Secretary shall notify the club of a
			demerit point suspension no later than close of business on the Wednesday prior to
			the round in which the suspension is to be served.
	7.12.3		All players in senior competitions shall accrue demerit points according to the
			following schedule.
		(i)	Five (5) points for each yellow card received.
		(ii)	Ten (10) points for each red card received.
	7.12.4		Demerit points shall expire eight (8) competition rounds after they were received.
	7.12.5		Following the serving of a suspension as outlined in 7.12.2 above, that player
			returns to a total of zero (0) demerit points.
	7.12.6		If a player plays in a round in which they were to be suspended under 7.12.2, the
			team in which that player played shall have a 5-0 loss recorded against it and the
			suspension shall be served in the next round in which the player's club has teams
			competing.
	7.12.7		Where a player receives two yellow cards for the same offence in the same match,

hence resulting in a red card, the player shall only receive a maximum of ten (10) points for that match.

- 7.12.8 A demerit point suspension shall be served separately and in addition to any suspension imposed by the Disputes Committee as described in By-Law 13.
 7.12.9 Where a player exceeds the demerit point limit specified in 7.12.2 in their last match
 - Where a player exceeds the demerit point limit specified in 7.12.2 in their last match for the season, the suspension shall be served in the first round of the next season.
 (i) If a player transferr clubs between seasons, they shall some the suspension as
 - (i) If a player transfers clubs between seasons, they shall serve the suspension as part of their new club.
 - Appealing a demerit point suspension
 Players may appeal a demerit point suspension to the Competition Committee within seven (7) days of exceeding the demerit limit specified in 7.12.2 only if it can be shown that all demerit points received by that player were given by one particular umpire within the period specified in 7.12.2. Individual yellow or red card decisions may not be appealed.
 - (ii) Teams shall not be punished under 7.12.6 where the demerit point suspension is under appeal.
 - (iii) Should an appeal be upheld, the most recent demerit point offence shall be rescinded and those demerit points deducted from the player's demerit point total.
 - (iv) Should an appeal be dismissed, the demerit point suspension shall be served in the next competition round following the appeal, in which the player's club has teams competing.



8. MATCHES.

8.1			Premiership points are awarded for fixtured matches as follows
	8.1.1		three points for a win or a forfeit
	8.1.2		one point for a draw
	8.1.3		The score for a forfeited match shall be 5 - 0 unless a better goal difference has been obtained.
8.2			If a team starts the match with less than eleven players, a player or players may join the game at any time as they become available, provided there are not already eleven players on the field for that team.
	8.2.1		The name of any player not taking the field shall be struck from the team sheet by the Captain and initialled by an Umpire.
8.3	8.3.1		No team shall be eligible to play with less than seven (7) of its registered players. Where there is a delay of more than ten minutes in the starting time of any match because one of the teams is not ready to commence, the team unable to commence shall give a walkover.
	8.3.2		When a walkover is declared, the opposing team shall win 5 goals to nil, and be awarded three premiership points.
	8.3.3		Where a team has prior knowledge that a walkover will be given that team shall notify the opposing team/ club, the Umpires Convenor and the Records Secretary of the walkover at least 24 hours prior to the fixtured time of the game.
8.4			Any team failing to play three consecutive matches shall be withdrawn for the remainder of the competition unless a satisfactory explanation can be furnished to the Competition subcommittee.
8.5			Except as otherwise provided by these By-Laws, no person other than the Umpires and the players actually taking part in the match shall be permitted to encroach upon the playing field whilst a match is in progress.
	8.5.1		Additional persons permitted onto the field shall be:
		a.	any person called onto the field by an umpire for the purpose of attending to an injured player.
		b.	in under 11 matches, one coach per team shall be permitted on any area of the field except inside either of the 25 yards areas.
	8.5.2		Any person or player who is permitted to encroach on the field during a match must comply with any direction of either of the umpires.
	8.5.3		Players and team officials not taking part in the match may occupy the team bench and dugout allocated to them. They may also occupy the portion of the playing arena between the centre line and the back line on the side of the field where their team bench is located. Players and team officials in this area must not affect the game in
8.6			progress by impeding players or umpires. Under age teams may apply for permission to play players who are less than 12 months over-age and are playing hockey for their first year. Date of birth shall be required by the Records Secretary.

9. DOUBLE UP RULE

A maximum of two players from a higher division are permitted to play twice in any fixture in a lower grade senior competition, to make a maximum of 11 players for the lower grade team.

- 9. 1.1 No club shall permit any one player to play twice each fixture on more than 25% of home and away games.
- 9.1.2 No player may play twice in any fixtured round during the finals.
- 9.13 Where a player plays twice in each fixture in a lower grade, he/ she may play only in the next lowest grade in which the Club has teams.
- 9.1.4 A player may play in two matches in one fixture in any higher graded team, subject to other provisions of Rule 9.2.
- 9.1.5 When a player plays twice in a fixtured round, the double up match shall be considered to be the second match played in that fixtured round.
- 9.2 Players in underage competitions may play twice in each fixture in different age competitions without limit.
 - 9.2.1 Players may not play twice in each fixture in the same age division on more than 25% of home and away games.
- 9.3 In default of By-Law 9 the opposing team will be awarded the match as a forfeit with a score of 5-0.
- 9.4 In justifiable circumstances, permission may be sought from the Match Committee to waive the conditions set out in 9.1, 9.2 and 9.3.

10. CANCELLATION OF MATCHES.

- 10.1 The Match Committee shall have the authority to cancel matches in the case of inclement weather or if the grounds are unfit for play.
 - 10.1.1 In the event of cancellation of matches, the Match Committee should immediately notify the Umpires' Convenor, clubs and local radio.
 - 10. 1. 2 If matches are cancelled under 10.1, the Match Committee shall decide whether matches shall be refixtured.
- 10.2 If prior to a match commencing, it is mutually agreed by the umpires and the team captains or coaches that the ground is unfit for play, the umpires may cancel the match and record their decision on the back of the scorecard.
 - 10.2.1 The teams involved may agree to reschedule the fixture to a date and time satisfactory to both and shall notify the Records Secretary.
- 10.3 If during the course of a game, the umpires and team captains or coaches consider that the ground or other playing conditions have become unfit for play, the match shall be abandoned and replayed at a mutually agreed time to both teams.



11. <u>FINALS.</u>

11.1			At the conclusion of the scheduled matches of the competition, the teams who are in the first four places of their competition shall be entitled to compete in the final series matches in their competition, except Junior competitions for Under 11 and lower age groups.
	11.1.1		Where, because of late entries or withdrawals, or subject to By-Laws, teams have had results removed from the record of scores, or there not being a "complete" home and away fixture, the Match Committee may permit an equalisation to be applied to the record of scores for the purpose of determining the positions in the grade. The procedure for Equalisation to be as follows: -
		(i)	The number of byes for each team shall be determined.
		(ii)	The points gained by each team shall be divided by the number of games played by each team multiplied by the number of games that should have been played added to the number of byes.
		(iii)	The resulting number of points shall be calculated to three decimal places to determine the final positions of each team in the grade.
		(iv)	The adjusted points should be rounded to the nearest integer, and rounded up when remainder equals 0.5 and shown on the ladder.
11.2			If teams are equal on "Premiership points", the following procedure shall apply:
		(i)	The team with the highest difference between "goals for" and "goals against" shall be the higher team.
		(ii)	Where teams are equal on goal difference, the team with higher "goals for" shall be the higher team.
		(iii)	Where teams are equal on "goals for", the team with the highest number of wins for the season shall be the higher team.
		(iv)	Where teams are equal on the number of wins for the season, sub rules (i), (ii), and (iii) shall be applied to the games played during the season between the teams concerned to determine the higher team.
		(v)	Should teams remain equal after following the above procedure, and a "higher team" result is required to determine final placings on the ladder for the purposes of finals four placings, placings will be determined by the toss of a coin.
11.3			Where any teams are ineligible to compete in finals matches as a result of having outstanding debts, all teams below them on the ladder shall be promoted accordingly for the purpose of competing in the finals.
11.4	11.4.1		The finals series shall be conducted as follows:
	11.4.1		The first semi-final shall be played between the teams holding first and second place in their competition and the second semi-final shall be played between the teams holding third and fourth place in their competition.
	11.4.2		The preliminary final shall be played between the winner of the second semi-final and the loser of the first semi-final.
	11.4.3		A grand final match shall be played between the winner of the first semi-final and the winner of the preliminary final.
11.5			The winner of the grand final match shall be the winner of the premiership of that competition. For Under 11 and lower competitions, the premiership team shall be the



team that finished in first position on the ladder after the completion of home and away matches.

11.6 In the event of a draw in a semi-final or preliminary final match an extra seven-and-a-half (7.5) minutes each way shall be played with the first team to score a goal being declared the winner ('Golden Goal'). If a draw still results the team that held the higher position in the competition at the end of the home and away matches shall be declared the winner.
11.7 In the event of a draw in a grand final match an extra seven-and-a-half (7.5) minutes each way shall be played with the first team to score a goal being declared the winner ('Golden Goal'). If a draw still results in an U13 grand final competition, the two teams are declared equal winners of the premiership of that competition. In other competitions the Tie-Breaker Rule as described in By-Law 11.8 shall apply and the winner of the tie-breaker shall be the winner of the premiership for that competition.
11.8 The Tie-Breaker Rule shall be a penalty shoot out competition conducted as follows:

PENALTY SHOOT-OUT COMPETITION:

In a shoot-out competition, five players from each team take a one-on-one shoot-out alternately against a defender from the other team as set out in this Regulation. The shoot-out competition comprises all series of shoot-outs required to determine a result. The following sets out both the playing Rules and the procedures to be followed.

11.8.1. Respective Team Managers/Captain should nominate five players to take and one player to defend the shoot-outs from those on the Team Sheet except as excluded below. A player nominated to defend the shootouts can also be nominated to take a shoot-out. No substitutions / replacements are permitted during the shoot-out competition other than as specified below.

11.8.2. Team Managers / Captains should sign the Shoot-out Competition form (where available) to confirm the nominations of the five players and the sequence of players to take the shoot-outs and submit the form to the Technical Officer on duty (if any) or to the lead Umpire of the Shoot-Out competition if no Technical Officer is present. If no Shoot-out Competition form is available, the Team Managers / Captains should number the five players on the written Team Sheet with a number in the sequence they are to take the shoot-out and submit to the Technical Officer on duty (if any) or to the lead Umpire of the Shoot-Out competition form is present.

11.8.3. The above procedures must be carried out promptly so that the first shoot-out can take place no later than within five (5) minutes of the end of the match.

11.8.4. A player who has been temporarily suspended (green or yellow card) may take part in the shoot-out competition even if the period of their suspension has not been completed at the end of the match.

A player who has been excluded permanently (red card) during the match cannot take part in that shoot-out competition.

11.8.5. The Umpire/s will specify in advance the goal to be used.

11.8.6. A coin is tossed; the team that wins the toss has the choice to take or defend the first shoot-out.

11.8.7. All persons listed on the written Team Sheet other than any player who has been excluded permanently (red card) during the match which leads to the shoot-out



competition are permitted to enter the field of play outside the 23m area used for the shoot-out but must be at least 10 metres from the spot where the ball is placed at the start of the shoot-out.

11.8.8. The goalkeeper / defending player of the team taking a shoot-out may be on the back-line outside the circle.

11.8.9. A player taking or defending a shoot-out may enter the 23m area for that purpose.

11.8.10. Players taking a shoot-out and also defending the shoot-outs taken by opponents are allowed reasonable time to take off their protective equipment to take their shoot-out and subsequently to put back on their protective equipment.

11.8.11. Five players from each team take a shoot-out alternately against the goalkeeper / defending player of the other team making a total of 10 shoot-outs.

11.8.12. Taking a shoot-out:

(a) the goalkeeper / defending player starts on or behind the goal-line between the goal posts;

(b) the ball is placed on the nearest 23m line opposite the centre of the goal;

(c) an attacker stands outside the 23m area near the ball;

(d) the Umpire signals to the technical table (if any) that the time may start;

(e) an official at the technical table (if any), starts the clock which

automatically issues an audible signal (the Technical Official may be required to step out on the pitch and adjudicate the time from there); If there is no technical table operating at the match, the second umpire shall blow a whistle to start a shoot-out and shall keep time.

(f) the attacker and the goalkeeper / defending player may then move in any direction;

(g) the shoot-out is completed when:

(i) 8 seconds has elapsed since the starting signal; or

(ii) a goal is scored; or

(iii) the attacker commits an offence; or

(iv) the goalkeeper / defending player commits an unintentional offence inside outside the circle in which case the shoot-out is re-taken by the same player against the same goalkeeper/defending player; or

(v) the goalkeeper / defending player commits an intentional offence inside or outside the circle, in which case a penalty stroke is awarded and taken; or

(vi) the ball goes out of play over the back-line or side-line; this includes the goalkeeper/defending player intentionally playing the ball over the backline.

11.8.13. If a penalty stroke is awarded as specified above, it can be taken and defended by any eligible player on the Match Sheet

11.8.14. The team scoring the most goals (or ahead by more goals than the other team has untaken shoot-outs available) is the winner.

11.8.15. A player may be suspended by a yellow or red card but not by a green card during the Shoot Out competition.

11.8.16. If during a shoot-out competition (including during any penalty stroke which is awarded) a player is suspended by a yellow or red card:



(a) that player takes no further part in that shoot-out competition and, unless a goalkeeper /defending player, cannot be replaced;

(b) the replacement for a suspended goalkeeper/defending player can only come from the five players of that team nominated to take part in the shoot-out competition:

(i) the replacement goalkeeper / defending player is allowed reasonable time to put on protective equipment similar to that which the goalkeeper / defending player they are replacing was wearing;

(ii) for taking their own shoot-out (or penalty stroke), this player is allowed reasonable time to take off their protective equipment to take their shoot-out and subsequently to put it on again.

(c) any shoot-out or penalty stroke due to be taken by a suspended player is forfeited; any goals scored by this player before being suspended count as a goal.

11.8.17. If during a shoot-out competition, a defending goalkeeper/defending player is incapacitated:

(a) that goalkeeper/defending player may be replaced by another player from among the players listed on the written Team Sheet for that particular match, except as excluded in this document or unless suspended by an Umpire during the shoot-out competition;(b) the replacement goalkeeper:

(i) is allowed reasonable time to put on protective equipment similar to that which the incapacitated goalkeeper / defending player was wearing;

(ii) if this replacement is also nominated to take a shoot-out, this player is allowed reasonable time to take off their protective equipment to take their shoot-out and subsequently to put it on again.

11.8.18. If during a shoot-out competition, an attacker is incapacitated, that attacker may be replaced by another player from among the players listed on the written Team Sheet for that particular match, except as excluded above or unless suspended by an Umpire during the shoot-out competition.

11.8.19. If an equal number of goals are scored after each team has taken five shoot-outs:

(a) a second series of five shoot-outs is taken with the same players, subject to the conditions specified in this document;

(b) the sequence in which the attackers take the shoot-outs need not be the same as in the first series;

(c) the team whose player took the first shoot-out in a series defends the first shoot-out of the next series;

(d) when one team has scored or been awarded one more goal than the opposing team after each team has taken the same number of shoot-outs, not necessarily being all five shoot outs, that team is the winner.

11.8.20. If an equal number of goals are scored after a second series of five shoot-outs, additional series of shoot-outs are taken with the same players subject to the conditions specified in this document:

(a) the sequence in which the attackers take the shoot-outs need not be the same in any subsequent series;

(b) all eligible players from each team must take a shoot-out before any one of them can take another; any shoot-out due to be taken by a suspended player is forfeited;(c) the team which starts each shoot-out series alternates for each series.



11.8.21. Unless varied by this document or the HG Competition By-Laws, the Rules of Hockey apply during a shoot-out.

11.9 No player shall be eligible to play in the semi finals, preliminary final, or grand final matches with any particular team unless:

- 11.9.1 He/she has played in at least 30% of the home and away rounds available for qualifying, with the TEAM in the current season.
- 11.9.2 He/she has played at least 50% of his/her games for the season in that team or a lower graded team, unless all matches played in a higher graded team were played in the first half of the season.
- 11.9.3 He/she shall not have played in more than 50% of rostered higher division games to be eligible to play in a lower division final.

11.10 In exceptional circumstances only, dispensation may be sought from the Match Committee for the conditions in By law 11.9 to be waived.

11.10.1 Dispensation may be sought under By-Law 11.10 if

- (i) the player concerned has played at least one-third of the matches available for the team in that division or a lower division AND
- (ii) they missed no fewer than three matches due to injury, representative appointment or unavoidable employment commitments where the club seeking dispensation shows that such injury, appointment or commitments prevented the player from participating in fixtured matches AND
- (iii) the player has made reasonable effort to fulfill the requirements for eligibility
- 11.10.2 The Match Committee may impose additional conditions on dispensation requests should it see fit to maintain fairness in the competition.
- 11.10.3 Requests for dispensation must be made in writing to the Match Committee and include the name of the player, the reason(s) for dispensation, supporting evidence for the dispensation, and the number of matches the player is expected to have competed in by the end of the season. The Match Committee has the right to modify these conditions from time to time as it sees fit.
- 11.11 Clubs must submit to the Competition Committee chairperson, a list of intending players for the finals, 5 days prior to any final, in order to determine the player's eligibility to play.
 11.12 Each team participating in a final match shall provide one ball to be used during the match.

12. UMPIRES.

- 12.1 The umpiring of all Association matches shall be controlled by the Association Umpires Manager, and the regulations in force from time to time.
- 12.2 The Umpires Convenor shall have power to co-opt members to assist him/ her in carrying out the necessary duties.
- 12.3 Clubs /teams shall provide umpires for scheduled matches as directed from time to time by the Umpires Convenor.
- 12.4. If the appointed umpire or umpires are not in attendance within ten minutes of the scheduled match starting time the coaches / captains of the teams concerned shall appoint and agree upon an umpire or umpires.
 - 12.4.1 If the coaches/ captains cannot agree upon an umpire or umpires then the match shall be postponed and both teams shall supply a report to the Competition Subcommittee Convenor who shall set down a time for the replay of the game.
- 12.5 All persons rostered to umpire any scheduled match shall wear clothing which is distinct from the teams playing.

13.10		No charge seeking to challenge the umpire's decision shall be heard unless the particulars of the charge show that in making such a decision the umpire contravened the Rules of Hockey or
13.11		 had no power within the Rules of Hockey to make such a decision AND the challenge is based on the interpretation of the Rules of Hockey and not on questions of fact (except insofar as the facts relate to the interpretation). Within a week of receiving particulars of any charge(s) not being a charge to which By-Law 13.10 relates the Honorary Secretary shall, giving at least three days notice,
